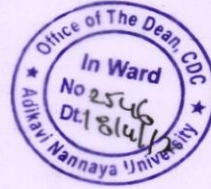

In the reference 1st to 3rd cited all the Collectors & District Magistrates/all the Superintendent of Polices/all the Head of Departments/ the Commissioner I&PR/the GA Dept.,(Publicity Cell), Secretariat/ the Secretary APLA/ the Secretary APLC/ the Secretary to Governor/ the Registrar, High Court of Judicature, AP/Registrars of all Universities were instructed to identify places where the national Flag is Hoisted to and follow the above instructions scrupulously and any deviation of the rules and disrespect to Honour of the National Flag will be viewed seriously and necessary action will be initiated against the concerned being the cognizable offence punishable under Flag Code of India, 2002 and prevention of Insults to National Honour Act, 1971 and to create awareness programme in advance duly campaigning through electronic media and to circulate the pamphlets.

All the members in the address entry are therefore requested to strictly Ban in manufactories, printing, supply, sale and usage of small size National Flag made of paper, plastic or other substances in relation to the Flag against the provision of the flag of code of India, 2002 prescribed under this code and as per explanation to section 2 of the prevention of Insults to National Honour Act, 1971.

They are also requested to enlighten, educate, create awareness by means of advertising in print and electronic media or in any other mode of Public campaigning on honour of National Flag in sensitized in proper usage in upholding honour of the National Flag shall treat the same with dignity and respect.
