

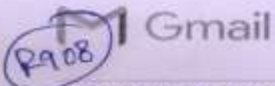

Respected Sir,

This is to inform you that as per the decision of the Vice chancellors' conference. A common web portal is designed to facilitate all the Universities to make ONLINE AFFILIATIONS. In this context, this Office has already informed that 'all the colleges affiliated to your University (Engineering, Pharmacy, B.Ed, B.PEd, Law, MBA, MCA and Degree Colleges ) have to upload the college details in the web portal designed on or before 15<sup>th</sup> April 2018'.

The last date to upload the data by the respective Colleges is extended upto 25<sup>th</sup> April 2018. The Universities has to complete the process of giving affiliation to the universities before May 5<sup>th</sup> 2018.

The Colleges who fail to get affiliation for the year 2018-19 will not be eligible to draw fee reimbursement as per the directions of Social welfare department. The colleges having permanent affiliation and Govt./Aided colleges should also upload the data to get the eligibility for fee reimbursement.

The Registrars are requested to communicate the same to the affiliated colleges under your jurisdiction.
