- i. **Student fellowship fund** (for non - scholarship holders/economically poor student's): student fellowship fund at the rate of 10% of the total fee of the admitted students in each section every year to be deposited in the joint account of University Registrar and Secretary & Correspondent of the college. The fellowship may be disbursed every year on any special occasion of the University to the respective college students, who are not having fee reimbursement facility and unable to bear the fee.

- ii. **Library & laboratory upgrading fund:** A fund to be created at the rate of 5% of the total fee of the total admitted students of college every year for upgrading of laboratories and libraries in their respective colleges. The college has to submit proof of up gradation in addition to the existing facilities/instruments/books to the office of the CDC every year at the time of applying for no-dues certificate from the University.
- iii. **Employee provident fund (EPF):** A Employee Provident Fund payment for all faculty and non-teaching staff of the college to be made and to be submitted to the office of the CDC every year at the time of applying for no-dues certificate from the University.
- iv. **Life & Health insurance Fund:** Submission of proof of payment towards Employees and student life & health (group) insurance every year at the time of applying for no-dues certificate from the University.

Accordingly a letter be addressed to the social welfare department and other departments stating that this fee structure be implemented from academic year 2017-18 subject to condition that it is in force until any uniform fee structure proposed by APSCHE, Hyderabad, in this regard.

The VC has further ordered that revised fee structure to Government colleges and aided courses in aided colleges be implemented for academic year 2017-18 after resolving through a meeting with principals of Govt. and aided colleges
